Protecting Your

Home—HomeCamera is an Internet home surveillance camera system that is easy to set up. Simply download the free Windows webcam security software, enter your HomeCamera user ID and password, enter a name for your webcam (such as “home” or “livingroom”), and hit Connect. You’re done! Log into your HomeCamera account from any browser on any PC (or even a PDA or mobile phone!) and click on View to access your webcam, as many times as you like, all day, every day, from anywhere in the world. Works on all webcams, and it supports motion detection. And it’s FREE!

It may be the answer to the HCCA Neighborhood Watch camera program. At this time, the service is

free but in early 2010 users will be charged \$29.95 per year. Go to **homecamera.com**. Under the support section of the home page you will find frequently asked questions. It has several features and it **supports CCTV cameras /“security cameras.”** The info/images are stored on a remote server for 30 days. In the case of a burglary, if your computer is stolen, you still have the video.

HomeCamera lets you share your cameras with other HomeCamera users—you decide who you want

to share them with. Use your existing Windows* PC for up to four cameras—there’s no need to buy expensive systems.

HomeCamera works with all webcams and even CCTV cameras. It includes support for motion detection—using cutting-edge technologies, it can detect movement and send pictures or videos to your mobile phone or your email address.

HomeCamera works on Windows XP and above. The disadvantage is it doesn’t work with Mac at this time and the cameras have to be hardwired.

Imagine, if in your block, just a couple of neighbors had their webcams looking out on the street and something goes down in the neighborhood. The images could be checked for the timeline of the event and come up with a picture of the suspect, vehicle or other good information for investigators. Before the event or after the event. And it would be controlled by individual neighbors (little sisters) not the government (BIG BROTHER). There are many possibilities with this system.

After a few arrests based on the videos and showed on TV, the word would get out that you don’t go to Hillcrest to commit crime. So consider getting the HomeCamera.

Safety Tips When

Traveling—If traveling by vehicle, know where you are going and how to get there and back. Obtain a map or download the latest available GPS data. **Check for construction detours;** for longer trips, get a weather forecast.

If traveling out-of-state, most states or state law enforcement agencies provide road-and-highway information either online or at a 1-800 number; **check** to see what conditions they report before leaving. Visit the Federal Highway Administration’s related webpage...

...for national, regional, and state-by-state **links** regarding traffic, closures, and other conditions. Inform a family member where you will be and when to expect you back; give them your route if they don’t know it.

Travel & conduct business during daylight hours if possible.

Wherever practical, use well-traveled and lighted thoroughfares. Bear in mind that routes that are congested during rush hour may be lightly traveled at other hours. Use freeways and arterial streets and avoid less-traveled roads as much as possible, especially when driving at night or in unfamiliar locations.
