### **VICE PRESIDENTS' MESSAGE**


Dear neighbors,

# I GUESS I'LL BE SHOVELIN' OFF (the sidewalk)

Several months ago, local news media announced that the city was tightening the enforcement of sidewalk snow removal requirements by both business and home owners. Here is a summary of what is expected of home residents.

FIRST: the good news. Some of us in Hillcrest with six foot sidewalks have been clearing the entire six foot width. Relax--one need only clear a minimum of 36 inches.

SECOND: residents must remove the snow and ice within the first eight hours of daylight after the snow ends.

Residents who fail to remove or cover snow or ice may be issued a notice of violation within 24 hours of failure to remove the snow or cover the ice. (There seems to be a discrepancy between this and the above paragraph.) But only one notice of violation may be issued in a 24 hour period for the same property. The fine for

residential property is \$25.00.

THIRD: property owners are also required to clear a path through the curb cuts and curb ramps.

FINALLY: residents who are disabled or 65 years of age or older are exempt from the penalties <u>if they have filed and been approved for an exemption</u>. It is important to file this application every year. Copies of this exemption form may be obtained via <u>leaf.dpw.dc.gov/</u>
WSAExemption/

When filing for an age exemption, proof of age must be provided with a copy of a government issued identification. If filing for a disability exemption, proof must be established either by participation in a government issued assistance program or a doctor's certificate. The details and particulars are listed on the exemption application.
