## Team from the D.C. Department of Transportation to Speak

At the open forum at the January meeting, the HCCA membership had raised several issues about transportation and traffic-related issues. Therefore, the HCCA board has invited a team of speakers from the D.C. Department of Transportation (DDOT) to address the following issues among others:

- The construction and management plan for the 11th Street Bridges Project
- The construction and management plan for the Pennsylvania Improvement Project
- How to get more sidewalks installed within the HCCA neighborhood? Process and timeline?
- What does it take in terms of process and timelines to get streets repaired or redone?
- Explain the traffic calming program on Branch Avenue from Pennsylvania Avenue into Maryland, and the adverse impact on some residential streets.
- Plans or interest in a Circulator bus connecting the Hillcrest area to Capitol Hill.

We look forward to welcoming DDOT to our March meeting to discuss these, and any other concerns the membership will raise.

### Tax Changes for 2010 Tax Filing Season

—In 2009, numerous tax filing initiatives were enacted. Following is a summary of key changes for tax payers filing their 2009 returns.

**Anacostia River and Prevention Fund:** Individuals are able to contribute to its clean up efforts. Fill out Schedule U, Part II, Line 3 on form D-40 or Line 9c on form D-40EZ.

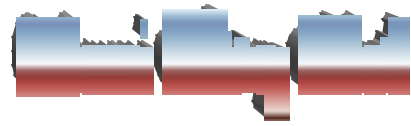
**Taxation of Compensation of Military Members and Spouses:** On Nov. 11, 2009, President Barack Obama signed the Military Spouses Residency Relief Act to prevent multiple state taxation on the income and property of military personnel serving in various tax jurisdictions because of military service. The act provides that a state or local tax jurisdiction cannot include the military compensation earned by nonresident service members to compute the income tax liability imposed on the non-military income earned by the service member.

**Refund directed to foreign account (IAT):** Electronic banking rules have changed. Refunds directed to an account outside the United States will be issued on a paper check.

**Recovery Act Decoupling:** Individuals will not be able to deduct the District of Columbia excise taxes on the purchase of motor vehicles whether they itemize or take the standard deduction.

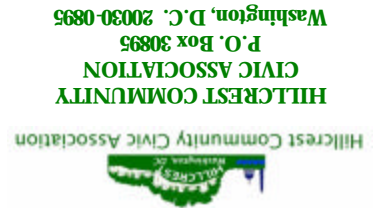

### 13 Things Your Burglar Won't Tell You



1. Of course I look familiar. I was here last week cleaning your carpets, painting your shutters, or delivering your new refrigerator.
2. Hey, thanks for letting me use the bathroom when I was working in your yard last week. While I was in there, I unlatched the back window to make my return a little easier.
3. Love those flowers. That tells me you have taste...and taste means there are nice things inside. Those yard toys your kids leave out always make me wonder what type of gaming system they have.
4. Yes, I really do look for newspapers piled up on the driveway. I might leave a pizza flyer in your front door to see how long it takes you to remove it.
5. If it snows while you're out of town, get a neighbor to create car and foot tracks into the house. Virgin drifts in the driveway are a dead giveaway.
6. If decorative glass is part of your front entrance, don't let your alarm company install the control pad where I can see if it's set. That makes it too easy.
7. A good security company alarms the window over the sink. And the windows on the second floor, which often access the master bedroom and your jewelry. It's not a bad idea to put motion detectors up there too.
8. It's raining, you're fumbling with your umbrella, and you forget to lock your door-understandable. But understand this: I don't take a day off because of bad weather.
