## HCCA BOARD RECOMMENDATIONS NEED YOUR INPUT AT THE MAY 6<sup>TH</sup> CIVIC ASSOCIATION MEETING



Please plan to attend the May HCCA meeting on May 6<sup>th</sup> to provide your input to the proposed board recommendations that will shape the future of the organization and the issues upon which it will focus.

In February, 2006 the HCCA Board of Directors participated in an all day retreat to analyze the current state of the organization, which included a review and identification of issues of concern to the community and the organization. At the April, 2006 HCCA meeting, the topics of major focus at the retreat were outlined and proposed next steps were identified. The HCCA membership will be asked, at the May 6<sup>th</sup> meeting, for their input and ideas about the proposed board recommendations. There will not be a guest speaker for May. Most of the meeting time will be devoted to allowing members to comment on the board's recommendations.

The meeting will be facilitated by Connie Spinner, a neighborhood resident and experienced facilitator, who has focused on working with groups in change. She has worked for over twenty years in education and community development, where she directed her efforts on improving quality of life for citizens in the District of Columbia. Connie served five years as a senior staff member at a national non-profit organization linking policy, practice, and strategic philanthropy to community-based school reform. And, for over 16 years, Connie has been employed as a professional consultant, providing training, curriculum design, and group facilitation to national and international organizations.

### **Message from the President**

*Dear Neighbor. Littering in the District of Columbia is an ongoing problem that is in need of stronger actions to abate. The Department of Public Works, who has the primary responsibility for enforcement of anti-littering laws, is not sufficient to serve as an adequate deterrent to littering. An increase in the fine for littering is needed and giving police officers, who currently don't have the responsibility for writing littering tickets, the responsibility to do, is also needed. The visual image of the District of Columbia is being adversely impacted by uncontrolled littering, illegal dumping, unlawful posting of advertisement signs on trees and lamps, graffiti, trucks hauling trash without protective coverings, etc. Legislation, programs, and initiatives, designed to discourage the foregoing illegal activities and create a sense of hope that things will get better, are needed to encourage community involvement and respect of the public space. The D.C. Council is considering giving police officers the authority to write tickets for littering, thanks to legislation introduced by Councilmember Kwame R. Brown, at-large Democrat and member of HCCA, which would allow police to fine people who leave a beer bottle on a curb or toss a fast-food bag out of a car window. Litter often ends up in area waterways and officials estimate that about 70 tons of trash are removed every month from the Anacostia River. If the City Council supports and passes this legislation that will engage police officers in writing littering tickets, the residents of the District of Columbia can receive some relief. I encourage members of our civic association to contact members of the City Council to support this bill that is intended to make for a cleaner city. Also, I encourage the members of our civic association to support political candidates who come out in support of strong proactive actions to make our city cleaner and a better place to live, work, and raise a family. ### **HCCA POLICY ON POLITICAL SPEAKERS**



In keeping with the mandate of the by-laws and, as a result of a discussion at the recent Board of Directors retreat, the Board passed a resolution at the April meeting of the Board to the effect that: "The HCCA will not allow political candidates to speak at monthly meetings unless all candidates running for that office are invited. The Ward 7 council member will have a regular place on the agenda. Should the Ward 7 council member be running for political office, that council member will be allowed to speak, but only about ward 7 business. He/she will not be allowed to mention the candidacy or any of the issues pertaining to the race." This is an appropriate action by which the board spells out just how the provision of the by-laws shall be enforced. It establishes a policy as a point of reference for any future request from political candidates.
