Scott Kratz To Discuss Bridge Recreation Project

Welcome Scott Kratz to the HCCA meeting in October. For the last 18 months, Kratz has been working with the Washington, D.C., Office of Planning to transform an old freeway bridge into a park above the Anacostia River. The old 11th Street Bridges that connect Capitol Hill with communities east of the river have reached the end of their lifespan, and replacement bridges are now under construction. Kratz is working with THEARC, a nonprofit in Ward 8, along with the Office of Planning and several District agencies to use the base of one of the bridges to create a one of a kind park for active recreation, environmental education and the arts.

Where tractor trailers once crossed the Anacostia River, this new bridge park will support an iconic new outdoor performance space, fruit tree orchard in an existing food desert, playground space incorporating principles of universal design, classroom teaching school children about local watersheds and kayak launches on the river. Kratz, who lives in Barracks Row in Ward 6, is the vice president for education at the National Building Museum, and has been involved in the education field for more than 20 years.

Procedures for Nomination and Election of HCCA Officers/Committee Chairs

In August, HCCA President Karen Williams announced that Linda Jackson would serve as the Chair of the HCCA Nominating Committee (NC) for the 2012 Elections. In September, the HCCA Board approved the nominating and election procedures, which follow the HCCA Bylaws and Roberts Rules of Order (RRO). The NC Chair also received approval from the Board to solicit additional members for the nominating committee.

Announcements were made to the HCCA Board and membership about the Board positions that will be vacant, by virtue of currently serving officials declining to serve for an additional term. Nominations can be made at or before the October meeting for any of the Board officer/committee chair positions. Hillcrest Announcements

Skyland Demolition Begins

Mayor Vincent C. Gray joined Ward 7 Councilmember Yvette Alexander, Ward 8 Councilmember Marion Barry and several Advisory Neighborhood Commissioners for the start of phased demolition of the Skyland Shopping Center – a long-stalled development project that will provide new retail, housing and amenities to Wards 7 and 8. “I made a promise to the District that we would move the redevelopment of Skyland forward as quickly as possible, and today is further evidence that we’re keeping faith with that commitment,” said Mayor Gray at a press conference Sept. 26. The Skyland Shopping Center is an 18-acre site at the intersections of Alabama Avenue, Good Hope Road and Naylor Road, SE, that will be transformed into more than 315,000 square feet of retail space to include a combination of national-brand retailers and neighborhood-serving shops and restaurants. Several HCCA members attended the demolition. The general consensus among them was “it was about time.” The project has been a focus for the HCCA for 23 years.

W Street Block Party

The 2900 block of W Street, SE, is hosting its annual block party on Oct. 6, from 3 to 6 p.m. The block will purchase all the menu items and paper goods but you can feel free to bring your favorite dish. They are asking for a small contribution of \$5 per person. Children under 5 are free. Chairs will be provided or you can bring your own for a fun afternoon of socializing after the HCCA meeting.

Anyone seeking to run for an office or committee chair, **must** reside in the Hillcrest community, as defined by the Association’s Bylaws, and also have their HCCA membership dues paid up. In addition, in order to vote, a person’s membership dues must be current and paid up.

At the October meeting, the NC Chair will announce a slate, comprised by the nominating committee, based on the latest available information. The HCCA President will then ask for any nominations from the floor. Any modifications/objections will be made at that time. In addition, candidates for office are encouraged to provide a **short paragraph** about themselves, including prior involvement in HCCA and community activities/position(s)

Winter Gardening

Fall is at the door and winter is approaching. What does that mean for us indoor gardeners? Your plants will thrive best in ideal conditions so it's time to make some adjustments, as the weather cools and the days shorten. Here're a few tips.

- ✓ Plants still have the tendency to reach toward a light source. Make sure your plants get enough sunlight. If your home doesn't get ample sunlight, you can buy plants that are appropriate for medium to low light environments. It's also good to rotate your plants for them to grow straight.
- ✓ Watering right would solve most problems. Use room temperature water. Too much dryness or too much wetness is bad for your plant. Make sure your containers and your soil have proper drainage.
- ✓ Bathe your plants occasionally. Use a spray bottle and gently shower your plants.
- ✓ Plants require ample fresh air. Plants tend to suffer a great deal if they are kept in smoky or stagnated air. Open windows near your plants occasionally
- ✓ Keep a check on your home temperature. Plants tend to grow well at a certain temperature i.e. 65-75 degrees at daytime and about 10 degrees lower at night.
- ✓ Consider fertilizing your plants regularly. You can use a liquid fertilizer and add it in small amounts when you water your plants.

and their vision on how they see the HCCA organization moving forward. This statement should be provided to the NC Chair no later than Oct. 10, 2012. These statements will be compiled and provided to the membership prior to voting at the November meeting and election. The NC Chair reserves the right to edit statements for brevity.

At the November 2012 meeting, the NC Chair and the Membership Chair will determine paid members, who are eligible to vote, and will issue each one a secret paper ballot. Any nominations from the floor at the November meeting will have to be write-in candidates. You must be present at the November meeting to vote.

A "Teller Committee," to be appointed by the President (not to include any nominating committee members), will count the ballots and announce the winners for each office/committee chair, before the November meeting adjourns.
