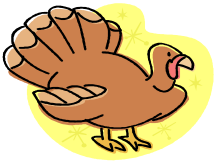

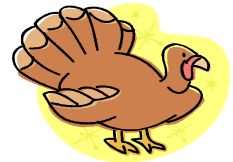

### NCRC REPRESENTATIVES TO PROVIDE UPDATE ON STATUS OF SKYLAND SHOPPING CENTER PROJECT AT NOVEMBER MEETING ON NOVEMBER 4<sup>TH</sup>



Executive Ted Risher from the National Capital Revitalization Corporation (NCRC) will provide an update on the re-development of the Skyland Shopping Center, and a presentation on initial conceptual designs developed in response to the community charette on August 19th. Once it receives an appropriate level of interest from an anchor (store) or anchors, NCRC will schedule a second community-wide charette to discuss finer aspects of the project's design with concerned residents. **Ted Risher**, Senior Development Manager, has worked for NCRC for over two years, during which time he has been responsible for the re-development of the Skyland Shopping Center. Prior to that, he worked for Bolan Smart Associates and Mid-City Urban, LLC as an office leasing broker and a financial analyst, respectively. Ted began his career in real estate as a project manager for the District of Columbia Housing Authority.

However, for this month's message, I want to continue to play my **one note** and that is: the appearance of the community has a lot to do with how we are perceived as residents of the community. The visual image of the District of Columbia is being adversely impacted by uncontrolled littering, illegal dumping, unlawful posting of advertisement signs on trees and lamps, graffiti, trucks hauling trash without protective coverings, etc. Legislation, programs, and initiatives designed to discourage the foregoing illegal activities in communities across the District are lacking and a low priority. The D.C. Council is considering giving police officers the authority to write tickets for littering, thanks to legislation introduced by Councilmember Kwame R. 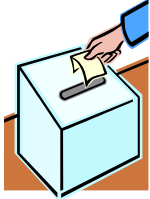

## CITIZEN ATLAS IS A WEALTH OF INFORMATION

Do you know your Voting Precinct? Police Service Area? Advisory Neighborhood Commission? ANC commissioner? You can find most of this information and much more on DC's Citizen Atlas. Go to [www.about.dc.gov](http://www.about.dc.gov) . Click "Find it", then "Where You Live". Type your address, then click "Make Report". The report provides the nearest library, recreation facility, fire station, hospital, post office, police district, voting precinct, PSA, Ward, ANC, neighborhood name, and more. If you want to know the name of your Advisory Neighborhood Commissioner, you'll first need to know your Single Member

District (SMD). Go to [www.dcboee.org](http://www.dcboee.org), the DC Board of Elections website. Under "Services", choose "Find Your Polling Place". You'll need to type in your street number, street name, and quadrant. The screen will show your ward, voting precinct and location, ANC and SMD. With this information you can locate your ANC commissioner and his/her contact information by going to [www.anc.dc.gov](http://www.anc.dc.gov) and choosing the appropriate ANC.

## **DHCD HOSTS A SERIES OF "NEEDS" MEETINGS**

Stan Jackson, Interim Director of the Dept of Housing and Community Development (DHCD), announces a series of public hearings on "Housing and Community Development Needs in the District of Columbia". The hearings will form a basis for developing the District's draft "Consolidated Plan for the District of Columbia Fiscal Year 2008 Action Plan" and the spending priorities utilizing federal entitlement funds. The public is invited to identify the needs of their communities and to comment on the Department's performance during fiscal year 2006, in meeting the District's housing and community development needs.

Residents and other stakeholders are strongly encouraged to come out and participate in the development of policies and programs in the following areas: 1) affordable housing; 2) special needs housing; 3) homelessness; 4) home ownership; and 5) community development and public service activities. The Department is also interested in receiving community feedback on innovative strategies to enhance community participation during this planning process. Four (4) public hearings will be held throughout the city during the month of November and their dates and locations are as follows:

- ◆ Thursday, November 30<sup>th</sup> at 6:30 p.m., Metropolitan Police Department, Regional Operations Command North, 801 Shepherd Street, NW
